The program therefore, offers solutions to address the complexities of feeding a growing global population while minimizing environmental impact.




Biodiversity Conservation.

activities in some of the communities of work especially in Albertine Graben where oil and gas activities are taking place.

The year 2023 opened up to new partnerships and collaborations from local to Global levels and this increased our coverage of work. For example, under the stopEACOP Campaign, Vuka Africa, Inclusive Green Economy Network East Africa (IGEN-EA) among others, we partnered with different organisations that are part of these movements and implemented Joint activities. If it wasn't through these movements and partnerships, we wouldn't have achieved most of the target for the year 2023.

Furthermore, allow me to thank in special way the CERAI community-based monitors in 10 districts of Uganda, which are affected by EACOP project. These people have done a great job by giving regular updates about the issues faced due to oil and gas projects in the area. The CBMs have further supported CERAI a lot in sustainability of our work even in our absence.

On behalf of the Board, we thank each and every one that have been part of our work in this year especially the whole staff at CERAI for standing strong in the shrinking civic space to defend rights of the oil affected communities. If it wasn't passion and resilience for our partners and CERIA staff, the year 2023 would not yield the organisation mandate.

We hope that the achievements made in 2023, will be guarded and inform our work in the year 2024. The board continues and promises to keep supporting the organisation together with partners to deliver the organisational mission and vision for the year 2024.

b). Executive summary from Director



Dear readers, welcome to the CERAI 2023 Annual report. CERAI's work in 2023 focused on the three programs that the organisation runs. The year 2023 results made achievements due to our work and shared below.

The year 2023 had some challenges including shrinking civic space, arrest of both Environmental and Human rights defenders and media shying away from capturing anti-oil and gas stories. All these challenges were lessons that empowered us and partners to keep changing strategies to operate in the hostile Environment.

Below I bring to your summary of the work the organisation did in the year 2023. Our work focused on community mobilisation on grassroots, advocacy through media and social media platforms, capacity building workshops for communities and increasing geographical coverage from local to Global levels.

Further our advocacy was centred on issues of oil and gas activities in the Albertine Graben. We focused our advocacy on green economic sectors (Agriculture, renewable energy, fisheries,) as opposed to fossil fuel projects (oil and gas activities). Through community Engagements and media, we advocated for renewable energy investments instead of fossil fuels to conserve and protect our environment.

Below I bring to you some of the key activities we implemented in the year 2023 and achievements. Our work was done from local to Global levels. This increased our coverage and reduced on the risks due to work in partnerships.

Implemented activities

a) Efforts to stop fossil fuel developments: In efforts to stop EACOP, CERAI facilitated formation of six stop EACOP groups both in oil-affected communities and in education institutions of Uganda. Three of these groups are in Hoima, Buliisa and Kikuube district and the remaining are in education institutions (Mbarara, Makerere and Kyambogo) universities.

These groups have actively done a tremendous job to keep the campaign running in their areas and the target is to build capacity of these groups and strengthen them to exert maximum pressure to the government of Uganda and Oil companies to drop this project.

- b) Community Engagements: We organized various community engagements with different stakeholders in environment and energy sectors. For example, in June 2023, CERAI organized community engagements with oil-affected communities with emphasis on youth to strengthen their capacity in reporting and documenting about oil and gas issues. We further supported youth activists for community visits in the villages being affected by oil and gas activities to see and observe exactly what is happening. This informed their advocacy through the year.
- c) Save River Rwizi Campaign: In April 2023, CERAI launched save River Rwizi campaign in western Uganda. River Rwizi is the largest river in Ankole-sub region and covers approximately 8,200km and pour its water in Lake Victoria through Sango Bay Forest. However much important this river is, it has lost 60% of its water catchment areas due to human activities and disposal of plastics by Nile breweries and coca cola companies in Mbarara city. In addition, two hundred people have illegally acquired over 500 hectares of land along this river for investments. Therefore, we organised a day of action and peaceful demonstration calling on the Mbarara capital city Authority and Nile breweries to stop the ongoing destruction of the river. We further petitioned the Nile breweries over the continuous disposal of wastes into the river that is source of livelihood to over 400million people in Ankole subregion.
- d) Capacity Building Trainings: In 2023 CERAI organised over 20 capacity building trainings for youth climate activists and youth leaders. The objective of these trainings was to build youth capacity to stand and defend rights of oil affected communities. Youth were also empowered to advocate for renewable energy as opposed Fossil fuel projects. Two hundred youth have been trained and their capacities enhanced.
- e) Save Bugoma Forest campaign: CERAI amplified advocacy to save Bugoma Forest that have been encroached on by Hoima sugar limited. Due to our continuous efforts and engagements, the boundary re-opening exercise was done. We wait for the report to be accessed by the public. We continue to advocate for restoration of degraded part of the forest and the year 2024, we shall keep on the advocacy to pressurise Hoima sugar limited to restore part of the forest that was cleared for sugar cane growing.
- f) Media Engagements: Due to the restrictive and repressive civic space for both Environmental and Human rights defenders, CERAI organised various engagements with media owners and generalist on the importance to report about Human rights violations that have come along with oil and gas projects. The engagements were done both at grassroot root levels with local journalists.
 and at National levels. This made some improvements and attentions to oil and gas issues.
 - and at National levels. This made some improvements and attentions to oil and gas issues, however much efforts are still needed to have independent media houses that are not influenced during the reporting.
- g) Global Days of Action. As part of Global campaigns, together with partners we organised Global days of action calling on the financial intuitions and Insurance companies to stop financing fossil fuel projects in Uganda. These actions were youth led and were done

randomly across the globe. For example, we organised day of action calling on standard chartered bank to drop financial support for the EACOP project. We further organised day of action calling on Marsh an insurance broker to stop outsourcing insurances for the EACOP project. The struggle resulted into over 24 banks pulling out from financing the EACOP project.

- h) Supporting communities (youth) to defend their rights. The ongoing oil and gas activities have posed a lot of violations to both human and Environment. Therefore, as part of strengthening youths' capacity, we organised three youth engagements to build their capacities in human rights and how they can keep operating in shrinking civic space to protect and defend their rights especially those affected by oil and gas activities. As of now, their capacities are built in human rights and they are pressuring the government of Uganda and oil companies to stop oil and gas injustices in the Albertine Graben.
- i) Organic farming for oil affected communities: Though series of training, we organised community on-farm trainings on smart agriculture to improve their production. Over 500 farmers benefited from these trainings. We further established a small demonstration farm in Kikuube district where farmers and other groups can go, learn and observe better methods of farming. We hope to extend these agricultural trainings to other nine districts affected by EACOP project.

Despite the above achievements, challenges and opportunities, I would like to thank each and every one who supported CERAI the year 2023. We hope for continuous support in the year 2024 as we build a better planet earth.


Priorities 2024
